## BEQUESTS

Include Feed Ontario as a beneficiary or donate a paid-up policy to give meaningfully without impacting your current finances.

## RETIREMENT ASSETS

Designate RRSP, RRIF, or registered annuities to Feed Ontario. Leave a legacy while minimizing taxes for your loved ones.

## CHARITABLE REMAINDER/LEAD TRUSTS

Receive lifetime income while ensuring Feed Ontario benefits later or give now while preserving assets for your loved ones.

## ENDOWMENT GIFT OR FUND

Give forever by creating an endowment fund that provides annual income to Feed Ontario during your lifetime or through your Will.
